1. Game stands as played Kelmendi Reserves 2 vs Williamburg Reserves 4
2. Kelmendi Reserves are fined \$250 for threatening and intimidating the referee
3. Kelmendi club will be placed on probation till June 30th 2020, any more similar incidents will be dealt in a more severe matter.
4. Kelmendi must pay the referee fee of \$80
5. The \$330 fine must be paid to CSL before Sunday's game of 11/24/19, or the game will be forfeited and also all subsequent games will be forfeited until the fines are paid.
