- Kid Super Samba will forfeit the game 0-3 to FC Westchester
- Kid Super Samba player Ndiaye Khadim is suspended 5 years from all soccer activities for assault to the referee and causing the game to be suspended.
- Kid Super Samba is fined \$500 for the actions of the player Ndiaye Khadim and for an intoxicated spectator from the Kid Super Samba team threatening the referee crew at the end of the game in the parking lot
