Re: **Appeal of 12-17-20 Arbitration Decision**

Dear Mr. Caverly:

On January 22, 2021, the ENYSSA Appeals Committee convened a hearing to hear KidSuper Samba AC present their appeal of a decision rendered by the ENYSSA Arbitration Board.

The Appeals Committee considered the following items in rendering their decision: Referee Reports; Arbitration Decision dated 12/17/20; KidSuper Samba letter of appeal dated 12/27/20 and Response letter dated 1/22/21; the video of the incident; and the testimony of William Caverly, President of the club.

After careful consideration of all the evidence and testimony presented during the appeal hearing the following decision was rendered:

- 1. The forfeit of the game with Westchester on 12/15/20 is affirmed. KidSuper Samba will loss game by a 0-3 score;**
- 2. The player for KidSuper Samba, Ndiaye Khadim, suspension is reduced from 5 years to 2 years plus a 2 year Probation period once he returns to play. The suspension will be as of 12/16/20 and continue until 12/16/22 at which time the player can return to play soccer but will be on probation until 12/16/24. Should Mr. Khadim violate his probation in a similar matter of what got him originally suspended, he will be suspended for the remaining 3 years plus whatever other penalty he may have to serve for the subsequent infraction.**
- 3. KidSuper Samba's fine of \$500.00 is reduced to \$250.00 for its failure to control its players and spectators/fans.**
